

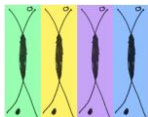

David has 20 years' experience of working in the energy sector, he was previously Chief Executive of the Energy Networks Association (ENA). During his time at the ENA he oversaw the introduction of the world leading Open Networks Programme and Gas Goes Green (hydrogen programme); he was a very strong advocate of the development of OFGEM's inspired Future Networks and Low Carbon Network Innovation Fund (LCNF); and is a strong advocate of a whole systems approach to energy: covering electricity, gas, heat and transport. Prior to his time at the ENA, David was Director of Corporate Affairs for the British Retail Consortium where he led the introduction of Chip and Pin for the retail sector. David was made an MBE in the Kings Birthday Honours in 2023, is a Life Fellow of the Royal Society of Arts, and also sits on the South Tees Development Corporation and Teesside Freeport Boards.

In his new role, David as co-founder and Executive Chairman, will oversee and drive the growth of the ExergInc Group of companies that includes FuturEnergySystems (FES), SmartCityZen (SCZ), Clean Heat Provision (CHP), Serendipity Energy Services (SES) and newly founded charity Seeking Wisdom Foundation (SWF).
